

Savannah Hosts Eventful Council Conference

Postal credit unions from across the country gathered in Savannah, Georgia, May 3-5 to hear from thought-leaders and network with colleagues facing the same challenges. The two and a half-day meeting was packed with information on payment trends, social media strategies, IT security, an economic outlook for credit unions and the Postal Service's current standing.

Filmmaker and futurist Ron Galloway delivered an eye-opening keynote presentation sharing the latest trends in payment technologies. He talked about how the mobile wallet has revolutionized consumer transactions making the following points:

- By 2016, 1.7 billion people will have a mobile phone but not a bank account
- Most financial assets today exist as purely digital records
- Businesses are transforming into data business, giants like Wal-Mart and Target leverage scale plus IT to predict future spending
- Apple has focused on the user experience and created a payment system that minimizes data risk to win over consumers

TrustCC Founder Tom Schauer was on also on hand to share his expertise on IT security. Jack McCall added levity with his wit and wisdom on embracing change in our fast-paced personal and professional lives. And, Holly Arter, Director of Media Planning shared tips and strategies for launching a successful social media program. Did you miss the conference?
