MID-TERM ELECTIONS AND THE IMPACT ON CREDIT UNIONS

The 2022 mid-term elections are finally over and while Republicans took back control of the House of Representatives, the final count -222 seats to 212 - will result in a smaller margin of error for new Speaker Kevin McCarthy (R-CA). For credit unions, the immediate effect is that Rep. Patrick McHenry (R-NC) will become the Chair of the House Financial Services Com-This will mean a more mittee. focused approach to the CFPB as Republicans will challenge the funding mechanism for Bureau.

On the Senate side, Democrats managed to maintain control of the chamber. For credit unions, this means that Board member Rodney Hood will most likely be replaced

when his term expires in August. If the Republicans had managed to gain control of the Senate (and therefore the confirmation process), it was expected that Sen. Mitch McConnell (R-KY) would have not allowed a replacement for Hood to progress through the Senate. However, now that Sen. Chuck Schumer (D-NY) is still Majority Leader, it is expected that a new NCUA Board member will be seated soon after Board member Hood's term is up.
